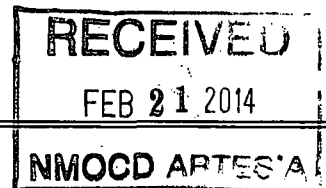
BOPCO, LP requests a variance to the interim reclamation submitted with APD. Plans submitted on East and South sides.
