

Tail: 390 sks C+1%PF1; 14.8 ppg & 1.33 yield.

Final circulating psi was 380 @ 3 bpm bumped plug to 880 psi, released psi, recovered 1 bbl of FW back, floats held. Full returns throughout job, circ 18 bbls cmt to surface.
