Spudded well on 2/12/14. Drilled 12-1/4" hole to 360'. Set 8-5/8" 24# J-55 csg @ 353'. Cmted w/280 sx (381 cf) cl "C" cmt w/2% PF-1 & 0.125# PF-29. Circ 167 sx cmt to pit. On 2/14/14, pressure tested 8-5/8" csg to 1500 psi for 30 min-OK.

Drilled 7-7/8" hole to TD4750' on 2/17/14. Ran open hole logs. Set 5-1/2" 17# J-55 production csg @ 4747'. Cmted w/lead 280 sx (540 cf) 35:65 poz "C" cmt w/5% salt, 6% gel, 2% R-3, & 0.125# CF & tailed w/160 sx (211 cf) cl "C" cmt w/0.5% PF-13, 0.2% PF-65, 2% PF-167, & 0.125# PF-29. Cmt pump broke, tried to circ out all cmt w/rig pump, lost circ. On 2/19/14, ran CBL & Temp Survey & found TOC behind 5-1/2" csg @ 600' w/base of cmt @ 4420'. Plan to consult Wesley Ingram w/BLM to repair well. Released drilling rig on 2/18/14.
