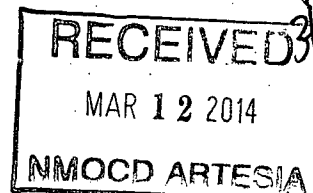

We are in the process of getting approval to build a frac pond in this area, but until then, we would like to frac from this Poseidon Tank.
