Cement with 200 sx Lite Premium Plus + 2.7 pps Salt + 5 pps Gilsonite @ 12.7 ppg and 240 sx Premium Plus + 2% CaCl + 1/4 pps Flocele @ 14.5 ppg. Circulate & WOC 24 hrs. Test casing to 1000 psi f/30 min. held ok. Drill 7-7/8" hole to 7640'. Ran 156 jts 5-1/2" 15.5#, J-55 LTC & 35 jts 5-1/2" 17#, J-55 LTC casing set @ 7631'. Cement with 630 sx Premium Plus + w/Nitrogen. TOC by Temp Survey 5220'.
