

Cemented with 575 sacks Class "C" + 2#/sx B288 + 2#/sx B289 + 4% D020 + 5#/sx D042 + 5% D044 + 0.2% D046 + 0.3% D112 + 0.125#/sx D130 (yld 2.21, wt 12.8). Tailed in with 275 sacks Class "C" + 0.125#/sx D130 + 0.2% D046 (yld 1.33, wt 14.8). Notified NMOCD of no returns. TOC at 241' per temperature survey. Cement 1" stage 1 with 25 sacks Class "C" + 0.125#/sx D130 + 0.2% D046 (yld 1.33, wt 14.8). WOC 4 hours. Stage 2 with 275 sacks Class "C" + 0.2% D046 + 0.125#/sx D130 (yld 1.33, wt 14.8). Stage 3 with 255 sacks Class "C" + 0.2% D046 + 0.125#/sx D130 (yld 1.33, wt 14.8). Circulated 25 sacks to surface.
