Went in with gauge ring; Could not get past 1,564 feet. Spot 30 sacks Class C cement at 5,545 feet.

At 4,315 feet pumped 30 sacks. WOC. Tag at 4,325 feet.

Pumped 30 sacks. WOC. Tag at 3,842 feet.

Cement plug consists of 85 sacks from 3,842 feet to 4,325 feet.

BLM approved casing cut at 1,560 feet and perf at 3,650 feet.

Pumped 40 sacks. Calculated TOC at 3,300 feet. Tagged at 3,396 feet. 100 feet went in backside.

Perf at 1,970 feet. Pressure test held. Went to 2,012 feet. Spotted 25 sacks. Tagged at 1,833 feet. Accepted as to plugging of the well here.

Liability under bond is retained until Surface restoration is completed.
