

The Inlet header at the facility malfunctioned allowing the release of fluid. The header is located on the backside of the facility. The header has been repaired.

**NMOCD ARTESIA**

Describe Area Affected and Cleanup Action Taken.\*

Initially 320 bbls were released from the inlet header, but 280 bbls were recovered with a vacuum truck. The spill area is located on the backside of the facility. Tetra Tech inspected site and collected samples to define spills extent. Soil that exceeded RRAL was removed and hauled away for proper disposal. Site was then brought up to surface grade with clean backfill material. Tetra Tech prepared closure report and submitted to NMOCD for review.
