



PROGRAM

1. MIRU PU.
2. Perforate 1st Bone Spring Sand in the interval 6500'-7500'
3. RIH packer on working string. Set packer at +/- 6450'. Test casing to 500 psi.
4. Frac the 1st Bone Spring formation with 1,800 Bbls of X-Link gel with 150,000 lbs of 20/40 white sand.
5. Unset packer and POH.
6. Clean the well to 11042' (PBD).
7. RIH 2-3/8" tubing and tubing anchor to +/-7600'
8. RIH rod pump. ND BOP. NU X-Mas Tree.
9. Put the well on production.

Expected production: 33 bopd x 30 bwpd x 250 mcf/d
