

A leak in the steel flow line caused the release. Shut off well and closed well valves. Vacuum truck(s) and roustabout crew called.

Describe Area Affected and Cleanup Action Taken.*

An approximate area of 20' X 50' (spray mist). The well was shut and the line repaired. The impacted area has been remediated with Micro Blaze and the poly flow line has been repaired. **Depth to Ground Water: >100' (approximately 125', Section 34, T21S-R31E, per Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: > 1000', SITE RANKING IS 0. Based on amount released, Micro Blaze treatment and repairs to poly line, Yates Petroleum Corporation requests closure.**
