The above location was due to be reclaimed by 02/24/2014. Fair Oil has plans to drill additional wells in the immediate 80 acres. The original plan was to use the Fair 17 Federal #1 location for the tank battery site for the additional wells Fair will drill in the W2 /NW of Sec 17-T17S, R31E. Fair still plans to utilize the location for both the tank battery site and support trailer location for the additional wells Fair will drill in the W2/NW of Sec 17, by doing so Fair can reduce the size of future locations. Fair has two active permits in Section 17, with plans to drill the first well within the next 45 to 60 days with the second well to follow by 60 days.

Fair requests a delay in any reclamation required for the Fair 17 Federal #1 location


