7/17/14 - Pumped 50 bbls FW down tubing to kill well. NU 5K BOP. Set 4-1/2 inch HM CIBP at 3742 ft. Loaded well with 32 bbls FW. Tested csg to 500 psi. Lost 300 psi in 1 min.

7/18-20/14 - Loaded hole with plugging mud and spotted 25 sx on CIBP at 3740 ft. Loaded and tested csg to 500 psi. Still lost 300 psi in 1 min. Tagged TOC on CIBP at 3375 ft. Shot squeeze holes at 1895 ft. Pumped 30 sx Class C in and outside of csg at 1895 ft. Calc TOC at 1750 ft. WOC. Tested csg to 500 psi and still lost 300 psi in 1 min. Tagged TOC at 1720 ft. Shot squeeze holes at 1408 ft.

7/21/14 - Pumped a 25 sx plug inside and outside csg at 1408 ft. WOC. Tagged TOC at 1300 ft. BLM approved tag. Shot squeeze holes at 880 ft. Pumped 25 sx in and out of csg at 880 ft. WOC. Tagged up at 1258 ft.

7/22/14 - Loaded csg with 1 bbl fresh water. Pressure tested csg to 500 psi. Lost 400 psi in 1 min. Tagged TOC at 661 ft. Spotted 35 sx Class C with 2 percent Cacl from 661-143 ft. WOC 4 hrs. Tagged
