RKI Exploration & Production reports plugging of the subject well. Work was conducted from May 28 through May 30, 2014, performed by BCM and Associates.

Set CIBP at 5,050 feet. Pumped 120 BBLS mud and 25 sacks cement from 4,803 feet to 5,050 feet. Set CIBP at 3,100 feet. Pumped 35 sacks cement from 2,754 feet to 3,100 feet. Tagged plug at 2,717 feet. Pumped 25 sacks cement from 2,203 feet to 2,450 feet. Tagged plug at 2,231 feet. Found casing free point at 850 feet. Set CIBP at 925 feet. Cut 8 5/8" casing at 827 feet for a total of 20 joints. Spotted 75 sacks cement from 587 feet to 920 feet. Tagged plug at 615 feet. Spotted 40 sacks of cement from 150 feet to surface.

Installed riser, cut off and removed dead men, and cleaned up well site on June 6, 2014.
