Spotted 70 sacks cement from 3,109 - 3,800 feet. WOC. 6/16/2014 tagged plug at 3,325 feet. Pressured up on casing, held 500 psi. Perfed casing at 1,641 feet. Pressured up on perms. Spotted 25 sacks cement with 290 CACL from 1,443 - 1,690 feet. WOC. Tagged plug at 1,441 feet. Perfed casing at 970 feet. Pressured up on perms to 500 psi. Held. Spotted 25 sacks cement from 825 - 1,020 feet. WOC. Tag plug at 839 feet. Cut off 5 1/2 inch casing at 240 feet. Spotted 50 sacks cement with 2 percent CACL from 115 to 300 feet. Tagged plug at 175 feet. Perfed casing at 60 feet. Squeezed 80 sacks cement. WOC. 6/18/2014 tagged plug at 160 feet. Pressure tested 13 7/8 inch casing. Held 1,200 psi. Spotted 45 sacks cement from 160 feet to surface.
