Describe Cause of Problem and Remedial Action Taken.*

Arapahoe Trucking failed to haul fluid causing the tanks to overflow. A vacuum truck was called out to recover standing fluid and was able to recover approximately 20bbbls of produced water. DFSI completed the Environmental Assessment, mapped the site and surface samples.

Describe Area Affected and Cleanup Action Taken.*

A total of 13,656 sq. ft. of impacted surface was determined. Twelve sample points were set, sampled and will be delineated. Once the site has been fully delineated a Remediation Work Plan will be submitted to both the BLM/NMOCD. All rules and regulations will be followed to closure of this site.
