TO DATE WE HAVE NOT MADE ANY OIL OR GAS PRODUCTION, ONLY WATER. LOOKING AT THE BHP WE BELIEVE OUR FLUID LEVEL IS VERY HIGH CAUSING TOO MUCH HYDROSTATIC PRESSURE TO PRODUCE FROM OUR OIL AND GAS ZONE. OVER THE NEXT FEW WEEKS WE PLAN TO MONITOR THE WELL LOOKING FOR SIGNS OF HYDROCARBONS AS WE DRAW THE FLUID LEVEL DOWN. IF NONE ARE SEEN OUR PLAN IS TO P&A THIS WELL IF THAT DECISION IS MADE, PROPER NOI WILL BE SUBMITTED FOR APPROVAL TO KEEP US IN COMPLIANCE WITH THE ACOI TERMINATION ON 03/26/2014.
