Burnett Oil is requesting permission to build an emergency pit at the Jackson B 75 well. While drilling we encountered a water flow of 1500 BBLs per hour at 540', increased to 2000 bbls per hour at 700' and increased to 3500 bbls per hour at 1040'. The emergency pit will be on the south side of the location and will be 100'x 100' and 12' deep. It will be lined with 30 mil plastic.

Spoke with BLM/Jim Amos on 6/3/14 and verbal permission was given to build the pit. OCD has also been notified.
