Notified BLM w/ phone call to On Call phone number, left notice on answering machine at 3:28 p.m. MST of MIT test on 10-3-14. Set CIBP at 9590' and dumped 35' Class "H" cement on top. RU Basic Energy pump truck on casing, loaded well w/ 136 bbls 2% Kcl, FL 8774' FS, closed blind rams and tested casing to 500 psi @ 15" with no loss of pressure, SWI and SDON. Bled down pressure and RIW w/ 2-3/8" notched collar, 2-3/8" cup type seating nipple, 301 joints 2-3/8" N80 tubing to 9490', 100' above CIBP at 9590' and 65' above cement. RU Basic Energy pump truck on tubing, vacuum trucks on casing, circulated well w/ 140 bbls fresh water w/ 27 gals Endura CI-811. ND BOP, NU flow tree, RU chart recorder for MIT test and pressured well to 550 psi for 30" w/ no loss of pressure. Note: No BLM representative on location. RDPU, cleaned location and left well shut in. Please see attached chart.
