Please be advised that RKI has recently discovered that cement had not been lifted into the 9-5/8 inch casing. Consequently, RKI had decided to perform a bullhead squeeze down the 9-5/8 inch x 5-1/2 inch annulus. This squeeze project has been satisfactorily performed with the top of cement being confirmed at approximately 1,850 feet (refer to attached CBL), enabling RKI to tie back into the intermediate casing string.
