Drilled 7-7/8" hole to TD4750' on 8/8/14. On 8/9/14, set 5-1/2" 17# J-55 production csg @ 4745'. Cmted w/lead 300 sx (571 cf) 35:65 poz "C" cmt w/5% PF-44, 6% PF-20, 0.2% PF-13, 0.125# PF-29, & 0.4# PF-46. Tailed w/770 sx (1024 cf) cl "C" cmt w/0.3% PF-13, 0.2% PF-65, 0.3% PF-606, 0.4# PF-46, & 0.125# PF-29. Circ 263 sx cmt to pit. Released drilling rig on 8/9/14. Plan to pressure test 5-1/2" csg during completion operations.
