 12/16/14 - Spotted 35' sx Class C Neat cement on top of CIBP. Calc TOC at 3184 ft. Tested casing to 500 psi. Perforated 4 holes at 1550 ft. Pumped through perms. Circulated out 8-5/8 inch x 4-1/2 inch, called BLM (Bob ok'd) pumping 50 sx Class C Neat cement and displaced to 1400 ft from shoe plug. WOC.
 12/17/14 - Tagged plug at 1330 ft. Perforated 4 holes at 1049 ft. Pumped 25 sx Class C Neat cement. Displaced to 950 ft. WOC. Did not tag. Pumped 25 sx Class C Neat cement. WOC.
 12/18/14 - Tagged plug at 835 ft. Perforated 4 holes at 170 ft. Pumped 90 sx Class C Neat cement and circulated to surface out 8-5/8 inch x 4-1/2 inch. ND BOP. Topped out casing.
 1/6/15 - Dug out cellar and cut off wellhead. Installed dry hole marker. Filled cellar. WELL IS PLUGGED AND ABANDONED.
