During the transfer of treated waters from the NW State 19 Recycling Containment, a valve located on the 10" transfer line vibrated shut, the maximum operating pressure for the 10" line was exceeded and the line ruptured. A vacuum truck was immediately brought to the release site, standing fluids were recovered.

Describe Area Affected and Cleanup Action Taken.\*

The affected area is located in Ut. M sec.29-T17S-R28E. This area was measured to be 195' L x 108' W. R.T. Hicks Consultants has been contracted for construction of a remediation work plan and the correction on the Staley State 20 release.
