 5/12/15 - Presure tested casing to 500 psi for 5 min, held good. Pumped 40 bbls fresh water down tubing. Released packer. Dropped 1.5" ball, pressured up to 1250 psi. Set a CIBP at 6149'. Circulated 130 bbls fresh water. Pressure tested plug to 500-psi for 5 min, held good. Spotted 25 sx Class "C" Neat cement on CIBP. Calc TOC is 5891'. Spotted 40 bbls salt water gel from 5891'-4175'. Spotted 120 sx Class "C" Neat cement from 4176'-3165'. Reverse circulated 30 bbls fresh water.
