1/17-20/15 - Acidized toe sleeve at 11,840 ft and frac sleeves 7,626 ft through 11,692 ft with 25,000 gallons 7-1/2 percent HCL acid, frac with a total of 4,075,346 lbs 20/40 RCS and WS.
2/7/15 - 2-7/8 inch 6.50 lb L-80 tubing set at 6,785 ft.

Note: Frac sleeve at 7,479 ft was plugged off.
