Mack Energy proposes to drill and set surface casing using an Auger Rig. BLM will be notified prior to spud of hole and setting/cementing of casing. A 20" hole will be drilled to competent bedrock at 180-200', based on COA. 8 5/8" 32# J-55 ST&C New pipe will be set and cemented w/350sx 6.32g/sx Class C + 1% PF1, yield 1.33, weight 14.8ppg, 100% excess. Casing will be capped and secured, cellar will be fenced. Mack Energy will move in a drilling rig capable of drilling to TD. Work will be done using a closed loop system.

This will eliminate the conductor pipe.

Conductor pipe will be set is wellbore issues are encountered.
