Location was built, but well was never drilled. Parallel returned the 200' x 200' drilling pit area to its natural state and re seeded the pit area 2 times resulting in good grass cover. The location pad built 200' x 400' w/ ~2200 yards of caliche was reclaimed and returned to its natural state w/ ~2200 yards of top soil. The pad area was then reseeded with grass seed mixture supplied by BLM. The area of the drilling pit and the location pad were fenced to keep the cattle traffic off of freshly seeded area. The caliche road leading into the Hop Sing was 2650' in length to the South was reclaimed and returned to its original dirt road.
