
Describe Cause of Problem and Remedial Action Taken.*

The water leg on the production tank was knocked down by the wind, causing the release. Vacuum truck(s) were called.

Describe Area Affected and Cleanup Action Taken.*

An approximate area of 35'X 18' within the lined/bermed battery. The valves were closed and all of the produced water was recovered (100%). Depth to Ground Water: > 100' (approximately 250', per ChevronTexaco Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 0. Based on all released produced water recovered and the battery being lined and bermed, Yates Petroleum Corporation requests closure.
