

Describe Cause of Problem and Remedial Action Taken.*

Internal corrosion of a steel nipple on the discharge line caused 18 bbls of produced water to leak onto the ground. A vacuum truck recovered 15 bbls of water and the nipple was replaced.

Describe Area Affected and Cleanup Action Taken.*

The affected area is inside the lined battery. Remediation will be completed by removing the impacted soil from the lined battery and replacing it with clean soil.
