10/18/05 – Set 7" 23# composite plug at 8500'. Perforate Atoka 8370'-8382' (73) and 8392'-8402' (61). Acidize with 1500g 7-1/2% MSA.

10/19/05 – Tagged composite plug at 8500'. Set packer above composite plug and attempt to test plug. Plug would not hold pressure. TOH with tubing and packer.

10/20/05 – Set 7" 23# CIBP at 8490' with 10' cement on top.

10/21/05 – Re-acidize Atoka 8370'-8402' with 1500g MSA.

11/1/05 – Frac Atoka 8370'-8402' with CO2 foam frac with 373 bbls fluid, 116 tons CO2, 50,000# 20/40 PRC Premium sand. AS-1 packer with 2.25" on/off tool at 8162'.
