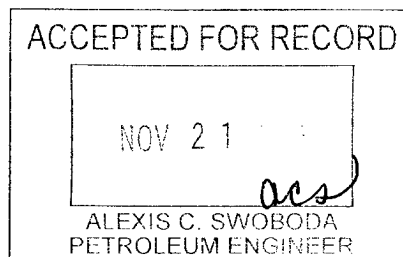

Circulate to surface. WOC 24 hrs. Test casing to 1000 psi f/30 min. held ok. Drill 11" hole to 3157'. Drilled 7-7/8" hole to 7470'. Ran 181 jts 5-1/2" 17# & 15.5#, J-55, LTC casing set at 7470'. Cement with 900 sx Litecrete + 1% D153 + 2% D024 + 0.05 gps D604AM + 0.03 gps M045 + 0.04 gps D801. TOC by Temp Survey 2905'.
