Tailed in with 200 sx Halliburton Premium Plus + 2% CaCl (yld 1.345, wt 14.8). Cement circulated to surface. Tested casing to 1000 psi for 30 min. WOC 39 hrs. Reduced hole to 7-7/8" and resumed drilling.

11/7/05 Reached TD 7850' at 2:15 PM. Set 5-1/2" 15.5# & 17# J-55 LT&C 8rd casing at 7850'. Float collar at 7803'. Cemented with 900 sx Premium Plus foamed single (yld 1.39, wt 14.5).
