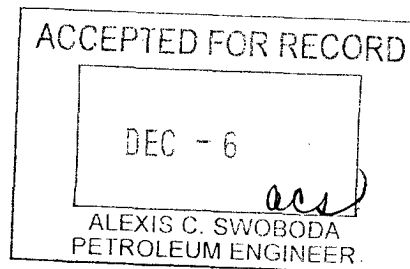

11/3-13/05 Install wellhead. Set rig anchors, lay flowline, set 456 pumping unit and tie in electricity. MI rig, drill out DV tool, tag TD @ 5336', (11/07) test 7" casing to 1000 PSI for 30 mins-held ok. POOH w/tbg. MI Hobbs & perforate from 4611' to 4886- total 28 hr at 2 SPF. Acidize same perforations w/total 2000 gals 15% FE acid. Frac same perforations in stages w/ total 52,710 gals WFG-R33 gel w/35,028 gals 20% hot HCL & 5,082 gals cool 15% HCL. Run total 5054' 2.875" tubing & 7/8" and 3/4" sucker rods. Put well to pumping to existing Stevens A comingled Tank Battery.
