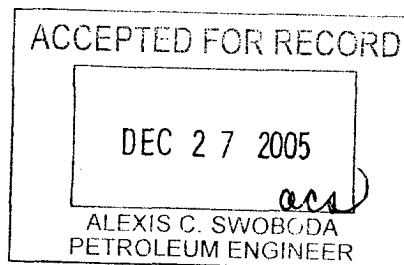
10/14/05 MIRU PU. Release packer and POOH with tubing and packer. RIH with bit scraper. POOH.

10/19/05 RIH with tubing and packer and set at 8,769'. Swab well.

10/20/05 Acidize with 3500 gals 7.5% HCl. Swab / flow back load.

10/24/05 Turn well to sales.
