Set 10k composite frac plug @ 11500'. Perf the Middle Morrow @ 11459' - 11485' (14 shots). Acidize w/ 1000 gal Clay Safe H acid. Swab/flow test. If decision made to frac, reperf @ 11459' - 11485' (42 shots). Frac down csg w/ appx 15,000# 18/40 versaprop. Set 10k composite frac plug @ 11400'. Perf the Morrow Lime @ 11278' - 11290' (13 shots). Acidize w/ 2000 gal NE Fe 15% HCl acid. Flow/swab test.
