Comments on Inspection:

Tank battery on south side of location has had multiple releases from the tanks. Soils in and around the tank battery have been impacted.

A complete site delineation and remediation is required. Submit remediation work plan based on results of site ranking and delineation. All soil remediation activities that occur on location must comply with the soil remediation guidelines in OCD publication "Guidelines For Remediation of Leaks, Spills, and Releases". This document may be found on the OCD web site: www.emnrd.state.nm.us/ocd, under Publications> Environmental Handbook> Miscellaneous

Guidelines> Remediation of Leaks, Spills and Releases.

Notify NMOCD District 2 Office 48 hours prior to any remediation work or prior to taking samples where results of the samples may be submitted to the OCD. Site remediation must be completed prior to March 16, 2006.

An old pit north of this well is open. Provide NMOCD District 2 Office with information on the nature and purpose of this pit prior to March 16, 2006.

In the event that a satisfactory response is not received to this letter of direction by the "Corrective Action Due By:" date shown above, further enforcement will occur. Such enforcement may include this office applying to the Division for an order summoning you to a hearing before a Divison Examiner in Santa Fe to show cause why you should not be ordered to permanently plug and abandon this well. Such a hearing may result in imposition of CIVIL PENALTIES for your violation of OCD rules.
