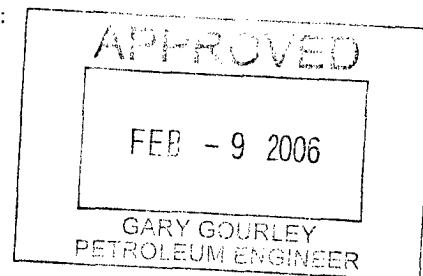

Set 6th plug with 20 sks Class C Neat at 60' to surface.
