Delta Petroleum Corp. proposes to restimulate the Reeves Federal #1 well in the existing Wolfcamp formation by adding new perforations and refracing down the production tubing. The following procedure will be employed pending regulatory approval:

- 1.) POOH with tubing and packer
- 2.) Reperforate the Wolfcamp formation @ 9,656'-58', 9,672'-76', 9,704'-10' & 9,726'-28'
- 3.) Rerun tubing and packer
- 4.) Fracture stimulate the existing Wolfcamp formation
- 5.) Test well & return to production
