- 1.) POOH with tubing and packer
- 2.) Reperforate the Wolfcamp formation @ 9,712'-14', 9,720'-22', 9,730'-34', 9,749'-51', 9,772'-76' & 9,792'-94'.
- 3.) Fracture stimulate the exisiting Wolfcamp formation
- 4.) Test well & return to production
