Please disregard this sundry as we inadvertently spud and are drilling the SHL for the Hummingbird Federal Com #8H (API #30-015-43051). These two wells are on the same pad site and we believe the dirt contractor that worked this pad site bladed the well site markers up and then went back and switched the marker locations when putting them back in the ground.

We plan to drill the #7H after we finish drilling the #8H location.

I have attached the copy of the notice of spud for the #8H just to show you I have submitted it to the BLM, I will also mail you a hard copy for your records.
