7/10-12/15 - Spotted a 25 sx cement plug on top of CIBP. TOC at 7412 ft. Spotted 35 sx Class C Neat cement at 6311 ft. Calc TOC at 6096 ft. Spotted 40 sx Class C Neat cement at 5635 ft. Calc TOC at 5536 ft. WOC.

7/13/15 - Tagged stage tool, cement top at 5536 ft. As per BLM OK. Pull up to 3764 ft. Spotted 35 sx Class C Neat cement across Bone Spring top up to 3594 ft. Pull up to 2216 ft. Spotted 35 sx Class C Neat cement across Glorieta top up to 2046 ft. Pulled up to 1227 ft. Spotted 40 sx Class C Neat cement across surface shoe up to 1057 ft.

7/14/15 - Tagged at 1068 ft. As per Michael Elliott with BLM, it's good. Spotted 40 sx Class C Neat cement from 150 ft up to surface. *Amilict*
