07/20/15: Pressure tested the casing to 2,200 PSI for 30 minutes; held okay.
Tested pipe rams, choke & kill line valves, and IBOP to 250PSI (Low) and 5,000 PSI (High). Tested blind rams to 250 PSI (Low) and 5,000 PSI (High). Tested back to pumps 250 Low) and 4,000 PSI (High). All tests successful. [Pressure Test Results Attached]
