

IR as per planned in AAPD plus reclamation north and east sides. Location bermed, slopes greater than 3:1, rips across the slope, corners rounded off to reclaim areas not needed for daily operations.

Remaining surface needed for daily operations is 126' x 178' or 0.51 acres. This is .28 acres more than planned.

Other information: well pad clean of spills, pump jack shale green, and secondary containment netted.
