 9/24/15 - Spotted 30 sx Class C Neat cement at 3432 ft. Calc TOC 3247 ft. Spotted 30 sx Class C Neat cement at 2164 ft. Calc TOC 1979 ft. Spotted 35 sx Class C Neat cement at 1183 ft. Calc TOC 968 ft. WOC. Tagged at 1020 ft.
 9/25-27/15 - ND BOP. Pumped 60 sx Class C Neat cement from 150 ft and circulated up to surface. Topped out casing.
