Describe Cause of Problem and Remedial Action Taken. * *A union on the tank eroded away, causing the pump to fail and shutdown. As a result 250 bbls of produced fluid was released and captured inside the fire wall. A vacuum truck was able to recover approximately 210 bbls.*

Describe Area Affected and Cleanup Action Taken. * *SESI delineated the affected area as detailed in a copy of their report dated 02/19/11 (an original of the report has been provided to the Artesia NMOCD Dist. Office) The affected area was remediated as discussed in section V. of the report. As noted in the report additional remediation will be necessary when the facility is inactive.*
