High wind damaged the water leg attached to the gun barrel causing a release of 20 bbl. oil, the impacted area was the bermed area of the tank battery, the impacted area located outside of the bermed area was measured to be 3'-21' wide x 105' Long.

Describe Area Affected and Cleanup Action Taken.*
The impacted material from the release was excavated and transported to Lea Land LLC. For disposal. Confirmation soil samples were collected, analytical results were received from Cardinal Laboratories, Inc. The excavated area was backfilled to grade and new berms were constructed at the tank battery.
