This is to give notice that on Monday, 4/11/16 we will begin work on getting the pit for the Duncan Federal #11 up to code.

- 1) We will remove the top soil covering the pit.
- 2) We will open the pit and move enough of the soil content contained within into a haul off bin in order to lower the top of the soil to 4' below ground level.
- 3) We will reclose the pit and cover it so that there is 4' of soil on top of the pit making it level with the ground level.
- 4) The haul off bin will be taken to the Gandy Marley disposal site.

IF THE PIT LINER'S INTEGRITY IS COMPROMIZED DURING RE-ENTRY, THE ENTIRE PIT CONTENTS SHALL BE REMOVED AND HAULED TO AN APPROVED DISPOSAL SITE AND SUBMIT A HAUL TICKET.
