6/22/16 – ND wellhead. Set a 4-1/2" CIBP at 2442'. Load hole with mud, tested to 500 psi. Spotted 25 sx Class "C" cement. Calc TOC 2079'. WOC.

6/23/16 – Tagged plug at 2251', NMOCD ok'd. Loaded and tested to 1000 psi. Spotted 30 sx Class "C" cement at 1061'. WOC.

Tagged at 707'. ND BOP. Spotted 35 sx Class "C" cement at 480', circulated to surface. Topped out casing.

7/1/16 – Dug out cellar. Busted cement up around wellhead. Cut off wellhead and installed dry hole marker. Filled cellar. **WELL IS PLUGGED AND ABANDONED.**
