The top of the producing interval of the well is 1692 FNL & 283 FEL (SENE) of Sec 21. The original "as drilled" plat assigned 40 acres at the surface location which is not in the producing interval (for a total of 320 acres). The original plat also did not outline the 40 acres at the BHL (SENW Sec 23).

A revised NMOCD Form C102 is attached assigning 280 acres to the well and correctly outlining same


