Thus this well's proration unit will be limited to 40 acres which will be the NE/NE of Sec 11. This portion of the section is Fee lands. This work is scheduled to be completed within the next 180 days.

Operator must receive approval from the State to recompleate.

The BLM will need a subsequent report once the well is recompleated so CA NMMMA94535 can be terminated.
