It should be noted that nitrogen is inherently found throughout the Pecos Slope Field.

Due to an unacceptable level of nitrogen found in the gas from this specific well, it has been necessary to temporarily Shut-in this well. It is our understanding that Transwestern has dictated the "acceptable level" of nitrogen in the gas they accept from Agave Energy Company (Purchaser).

Last Production Date: May 2012

The protracted status of this specific well is due to the failures of Agave Energy Company in the design, the construction, and operation of their nitrogen removal plant.

It is our intent to return this specific well to production in the next 30 days.
